NATIONAL STUDENTS

Considering the provisions of the Tuition Fee Regulations of the University of Lisbon, published in Despacho n.º 5621/2015, of May 27.

Considering that, by Resolution of the General Council of ULisboa, on September 29, 2025, the tuition fees for the academic year 2025-2026 were approved for the 3 study cycles; Considering also that it is the responsibility of the FFUL Management Council to determine the number of installments of the annual tuition fee, the respective dates and other related matters, in accordance with Article 31 of the Estatutos da FFUL;

Considering that, with the publication of Law No. 2/2020, of March 31, the annual tuition fees must be paid in at least ten installments;

C. School Insurance and Enrollment or Registration Fee

At the time of enrollment/registration, students are required to pay the first tuition fee installment, the school insurance, and the enrollment or registration fee. Erasmus students are only required to pay the school insurance fee at the time of enrollment.

D. Scholarship Student of ULisboa Social Services

As established in the ULisboa tuition regulations:

- a) Scholarship students of the ULisboa Social Services, as well as those who have applied for a scholarship and are awaiting the decision, will only be required to start the payment of the tuition fees from the moment they are notified of the decision on their scholarship request. No late payment interest will be applied until the scholarship decision has been issued;
- b) If the scholarship request is denied, students must pay the tuition fees already due within ten days from the date of notification of the denial.

E. Master's Students (2nd Cycle) – With Incomplete Credits

Master's students enrolling in up to 15 ECTS in order to complete the curricular component of their study program during that academic year may pay tuition fees proportional to the number of ECTS in which they are enrolled. The enrollment fee and school insurance are added to these amounts.

F. Master's Students (2nd Cycle) – Requesting an Extension of Final Work Submission

Master's students who are not in debt for any portion of the annual tuition for their course, and who, for duly justified reasons approved by the respective Coordinator, wish to have additional time to submit their final work, must submit an extension request. They will be subject to a monthly tuition fee calculated based on the annual tuition of the 2nd Year of the Course, until the dissertation/internship report is submitted.

G. PhD Students - Requesting an Extension for Final Work Submission

Doctoral students who are not in debt for any portion of the annual tuition, and who, for duly justified reasons approved by the respective Coordinator, wish to have additional time to submit their final work, must submit an extension request. They will be subject to a monthly tuition fee calculated based on the annual tuition of the doctorate program, until the thesis is submitted.

H. Standalone Course Units

The amounts related to application, enrollment, and tuition for individual curricular units are established in a specific executive order.

I. Extracurricular Course Units

All students enrolled in the 1st, 2nd and 3rd cycles at FFUL may apply for extracurricular units according to deadlines set by the Academic Services. Tuition is calculated based on the number of ECTS in which the student enrolls, specifically:

- a) Integrated Master's in Pharmaceutical Sciences – 15€ per ECTS;
- b) Other FFUL Master's programs – 35€ per ECTS.

J. Students under Ulisboa Mobility Program

Rules regarding enrollment in curricular units under the Internal Mobility program of the University of Lisbon are regulated by the Despacho Reitoral of January 31, 2022.

No additional tuition fees are due from the student, and the tuition portion associated with enrollment is transferred between the home school, the host school, and the ULisboa Rectorate.

K. Tuition Payment Plan

As established in the Regulamento de Propinas da ULisboa:

- a) Students in debt may request a specific payment plan from the FFUL Management Council, provided they justify their temporary inability to pay the tuition.
- b) Specific plans for the payment of outstanding tuition cannot extend beyond the academic year following the year in which the debt occurred.
- c) Non-compliance with the agreed plan results in the cancellation of the students' enrollment for the current academic year. In case of permanent non-compliance, the student's curricular acts will be declared null and cannot be certified.

L. Changes to Tuition and Fees Billing

Whenever changes to billing information related to tuition or other fees are required, students must not proceed with any payment until the changes have been duly processed in their student account. Payments made before the update is completed cannot be reversed, and it is not possible to modify billing details for payments already issued or for previous academic years.

M. Non-Compliance with Tuition Payment

As established in the Regulamento de Propinas da ULisboa:

- a) Students who do not pay tuition within the established deadlines are subject to the payment of the amount due plus interest.



- b) The interest referred in the previous paragraph shall be payable from the due date of each of the outstanding instalments.
- c) Non-payment of tuition results in the non-recognition of academic acts performed during the period to which the obligation refers.
- d) Non-payment of outstanding tuition gives FFUL the right to enforce payment through the Autoridade Tributária e Aduaneira via the fiscal execution process provided for in the Código de Procedimento e de Processo Tributário.
