FARM-ID intends to hire a Research Technician within the scope of the research project reference sim foi (Project No. 16199), entitled: “Proteolysis-targeting chimeric technology for the development of mutant p53-based anticancer drugs”, funded by national funds from the Portuguese Foundation for Science and Technology (FCT, I.P.) and by the European Regional Development Fund (FEDER) through the Lisbon Regional Program Management Authority, for the development of the activities listed below:

1. Synthesis and characterization of PROTACs and their intermediates;
2. In vitro evaluation of the activity of PROTACs;
3. Support the technical management of the project, ensuring follow-up, results organization, and communication with the research team.

What FARM-ID Offers: The selected candidate will receive a gross monthly base salary of 1,442.57€ (one thousand four hundred and forty-two euros and fifty-seven cents), as well as holiday and Christmas bonuses, subject to applicable taxes and legal deductions in accordance with the Labor Code. A daily meal allowance of 6.00€ will also be provided.

Eligibility criteria

Application Documentes:

1. *Curriculum Vitae* including the necessary information for assessment of the application;
2. Document proving the award of a bachelor's degree in the scientific area of the competition (if awarded by a Portuguese Higher Education Institution) or a copy of the degree recognition (if awarded by a Foreign Higher Education Institution);
3. Motivation letter expressing interest in the Research Technician position, highlighting relevant academic and professional experience, especially in relation to the preferred qualifications listed in this notice;

All application documents must be submitted in Portuguese or English.

No documents that should have been submitted during the application phase may be submitted after the deadline indicated in the notice. Failure to meet the deadline, or failure to submit the required documents, will result in exclusion from the selection process.

Selection process

Evaluation Criteria: Applications will be evaluated by the Selection Committee using the following methods:

- Curriculum Evaluation (80%) and Motivation Letter (20%).

If necessary, an individual interview will be conducted with the top 3 candidates, with a weighting of 40% and a maximum duration of 30 minutes, to objectively and systematically assess the following criteria:

- Knowledge of the Field (KF);
- Verbal Expression and Fluency (VEF);
- Motivation (M);
- Critical Thinking (CT).

The interview score will be obtained through the simple arithmetic mean of the scores assigned to each evaluation criterion, which will be assessed according to the following parameters: Excellent (20 points), Good (16 points), Satisfactory (12 points), Limited (8 points), and Insufficient (4 points), based on the completion of an individual evaluation form for each candidate.

Final Classification: The final score will result from the sum of the points obtained in the Candidate's Merit assessment, and an individual evaluation form will be completed for each

candidate. If an individual interview is conducted, the Curriculum Assessment together with the Motivation Letter will account for 60% of the final score, and the Interview will account for the remaining 40%.
